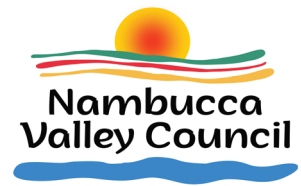

### Gumma Reserve

The Nambucca Valley Council, as Reserve Manager, has made improvements to Gumma Reserve.

This brochure provides information to all campers and day users visiting Gumma Reserve.

Gumma Reserve camp area is surrounded by unique Endangered Ecological Communities of local wildlife and all care must be taken with the surrounding environment and wildlife in the Reserve and the adjoining Gaagal Wanggaan (South Beach) National Park.

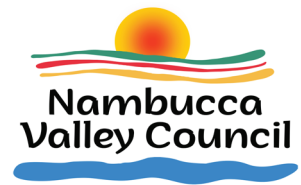

## Terms and Conditions

### Fees and charges

The Reserve is identified as a Primitive camping ground and has onsite Contracted Managers at various times throughout the year that have the authority to enforce terms and conditions. Gumma Reserve is not a free camping ground. Council's Contracted Managers will collect fees daily. Fees are payable by EFTPOS only (no cash) for the full time of your stay. If you are unable to pay you will be asked to leave.

Contracted Managers will determine how your site is charged: This will depend on what is set up and how it is set up.

Any separate tents or swags will be charged at a separate cost. Payment of fees indicates an agreement to the terms and conditions.

Refunds are only available if you are asked to leave for flood or fire. We do not transfer fees between sites.

If you are not happy with our fees or terms and conditions you have the choice not to stay.

Maximum time allowed to stay is 30 nights in 12 months.

**PERMANENT CAMPING IS NOT ALLOWED.**

### All Year Fees

Families: \$33 per night. Families will only consist of up to 4 people. Family sites allow for 1 extra tent

Children must be between the ages of 4 and 15. \$10 per extra child per day

### On Season Fees

NSW School Holidays April, September/October, December/January

Fee: \$28 - 1 person per night  
\$33 - 2 people per night  
\$12 per night for each additional person  
Infant 0-4 years free

### Off Season Fees

Fee: \$22 - 1 person per night  
\$28 - 2 people per night  
\$12 per night for each additional person

### Responsibilities

You are responsible for the actions of your guests at the camp-site for the duration of your stay. You must ensure that all guests and visitors comply with these terms and conditions.

### Garbage

- Please keep your site clean
  - All rubbish related to food and beverages is to be placed in the rubbish skip.
  - Broken chairs, tents, gazebos, tyres, gas bottles, crab traps and any other camping gear is not considered rubbish and must be taken with you when you leave.
  - Anything not taken will be considered as being dumped and penalties will apply.
  - Council has provided one reserve bin for the use of all campers.
- Use your own bin and empty it into the reserve bin.

### Noise

- Please be considerate of other campers and keep noise to a minimum during the hours of 10pm and 7am.
- No Generators during the hours of 8pm and 8am
- Any excessive noise will be considered a breach of terms and conditions and your stay will be terminated.

### Pets

- Dogs are permitted provided that they are kept on a leash at all times, are not aggressive or excessively noisy and you clean up after them, bags are provided for this purpose.
- Cats are not permitted
- Any breach of the terms relating to dogs or cats will result in your stay being terminated and fines will apply.

## Facilities

You have the use of the existing facilities provided in this primitive camping ground during your stay.

Unpowered and undesignated sites.

- An amenities block with flushing toilets.
- A dump point for caravans and campers.
- The picnic tables are to be shared and may not be claimed or reserved as part of your camp site.
- A boat ramp.
- Where possible please bring your own wood.
- Water is available for use at your camp site.
- It is not for washing your feet under, brushing your teeth under or washing yourself under
- If possible please bring your own water.
- Please use a container and take water to your site.

## Fires

**Fires are not permitted on total fire ban days**

**Collecting fire wood from the surrounding areas of the Reserve is strictly prohibited.**

**Penalties apply**

Fires are permitted under the following conditions:

- Fires are only permitted within your own stove, pig or BBQ
- Fires should be attended to by a responsible adult at all times
- Extinguish fires before bed

## Caravan and Camping Fire Safety

**Be Prepared**

- A fire can be terrifying, with strong winds, intense heat, flames and thick smoke
- Ensure that your Caravan has a smoke alarm, fire extinguisher and fire blanket
- Electrical and gas equipment must be secure, appropriately fitted, in good working order, and turned off while travelling
- A Survival kit should include a working battery operated radio, protective clothing, woolen blankets and water

**If you're caught in a fire:**

- Call Triple Zero 000
- Park off the road in a clear area away from trees
- Face your car towards the fire
- Turn off the engine and turn on headlights and hazard lights
- Close windows and air vents
- Stay low in the car to protect yourself from radiant heat
- Cover yourself with a woolen blanket
- Drink water and cover your mouth with a damp cloth
- Stay down until the sound of the fire has passed



## Setting up your site.

New primitive camping ground regulations only allow for 3 meter separation between sites for tents, unless additional tents are required on the same site.

(Please ensure your caravan is not blocking access for other campers to other camping sites allowing 6 m separation or you will be asked to move). Day visitors are not to set up in camping area at all times.

Caravans and camper trailers require a 6 meter separation with 1 tent allowed on these sites for children within the 6 meter area.

Camping Vehicles within the creek fenced area are required to park at a right angle to the creek. All vehicles and trailers must be parked to the front of the site, not beside it.

All vehicles within the remainder of the reserve must be kept on your camp site, with a maximum of 2 vehicles allowed or 1 vehicle and 1 x trailer.

If you are unable to find a site that meets the above terms and conditions the Reserve is considered FULL and you will not be able to stay.
