Review of Terms of Reference

Executive Leadership Team of Council had a few additional suggestions for the Terms of Reference:

- That the name be changed to "Nambucca Valley Disability Access & Inclusion Committee"
- Moved the Disability Inclusion Action Plan (DIAP) to the top of the list of objectives.
- Voting rights of organisations one organisation = 1 vote.
- Addition of a quorum as 50% of members plus 1
- Have accepted the return to monthly meetings as long as attendance numbers warrant it. Open to review.

Discussion:

What is our official membership numbers (to understand our quorum)? Previous quorum was 5 members.

What are the voting rights of the Councillor delegates on the Committee?

Discussed the number of voting members on the committee and Jocelyn to confirm. Suggestion of list of members and for each member to provide a short blurb about themselves.

Action:

Jocelyn to confirm Councillor delegates and voting rights, Committee members, advise committee and update Terms of Reference accordingly.

Guest Speaker - Reanna Ussher – Community Engagement Officer (Road Safety)

Reanna would like to discuss with the committee about how NVDIAC can inform our road safety.

Committee can raise issues with Reanna over time.

Issues raised by Committee:

The lack of pedestrian crossing at Aiden St Scotts Head and the confusion that the speed hump is a crossing. Reanna advises the Traffic Committee is investigating, there are challenges with rules and restrictions on pedestrian crossings and the loss of parking.

Driver responsibility in shared zones

- Reanna looking at delivering education on shared zones
- Police would need to monitor driver behavior
- Identification of shared zones flashing lights, patterns on the road or different pavement (like Coffs Harbour Central)

Council's best lever for pedestrian safety projects is the PAMP

Action: Jocelyn to provide Renna's contact details to Committee members should they have further ideas to raise.

Disability Inclusion Action Plan

- Final report submitted end of Nov 2024 (attached)
- Opportunity to update current DIAP must be submitted by end June 2025.
- Disability Inclusion Action Plan review community survey

Discussion:

Proposed changes to existing plan

Promoting positive community attitudes and behaviours:

- Woolworths quiet time/space do our local Woolworths offer this?
 Promote that.
- Factsheets and toolkits on how to be an accessible business.
 Education around disabilities that aren't physical, including mental health, and education around being a good employer for people with disability.
- Sport opportunities: Are there any local sporting groups for people with disability? We can promote
- The Sunflower program discussed by Busways promote

Creating liveable communities:

- Installation of disability accessible play equipment (remove Ferry St playground fencing item and replace with this action for identified playgrounds
- Macksville Memorial Pool accessibility indoor pool is preferred by people with disability, especially females, as the accessibility is better and less exposure to sun. However, accessing that pool with all the activities makes it difficult. People try to work with the published times, however, they change with no notice.
- Swimming teachers' awareness of disabilities like autism and how to manage that in students. The pool is an overwhelming environment.
- Nambucca Heads and Macksville main street shopfronts are not accessible.
- Advocacy for building standards that all new builds are accessible.
- Increased sand at VWall coming over the footpath from new beach solutions?

Supporting access to meaningful employment:

- Disability employment organisations may be able to help Council understand other actions they could take.
- Survey of businesses disability accessible, disability employer, what are the incentives for businesses/small businesses to provide opportunities for people with disability. Regional community disadvantages.
- Local businesses need education afraid to take the step and learn about it and worry it is about additional cost and support, and not realising what is available to assist them.
- Commissioner for Disability Employment.
- Promote excellence in access acknowledging businesses.
- Community engagement
- Lived experience survey able-bodied people provided wheelchairs to attempt to access and get around town, and see life from the perspective of a person with disability
- Website "the field" advertises people with disability looking for jobs. Profile provides information on their skills and needs. Awareness of this website?

Improving access to systems and processes:

- Previous DIAP deliverables were about telecommunications upgrades, not disability.
- How people with disability can do business with council pay rates, register their dog. Utilising hearing loops and other technology on council facilities. This is what needs to be considered in this section of the DIAP.

Timeline for DIAP revision:

25 March	Draft survey brought to Committee for approval
April	Launch survey Committee, Councillors and staff to hold pop up sessions to engage feedback Share with disability support organisations. Promote across media and socials
End April	Close survey and begin analysis
27 May	Report on survey and draft DIAP Action items in response for Committee discussion and endorsement
June	Endorsed by Council and submitted to Department of Communities & Justice.
